

Ordinance No. 1095

AN ORDINANCE adopting the 1960 Cumulative Supplement of The Code of The City of Alexandria, Virginia, 1953; providing for the repeal of ordinances not included therein, except as herein expressly saved from repeal, and for other purposes as hereinafter set forth.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That the chapters and sections embraced in the "1960 Cumulative Supplement of The Code of the City of Alexandria, Virginia, 1953", are adopted as and shall constitute the "1960 Cumulative Supplement of The Code of the City of Alexandria, Virginia, 1953."

Section 2. That all provisions of said 1960 Cumulative Supplement shall be in force and effect on and after the 15th day of December, 1960; and all ordinances of a general and permanent nature adopted between May 1, 1953, and July 27, 1960, and not contained in the 1960 Cumulative Supplement, except such ordinances of a general and permanent nature as may be saved from repeal by Section 3 of this Ordinance, are hereby repealed from and after the 15th day of December, 1960.

Section 3. That the repeal provided for in Section 2 of this Ordinance shall not affect any offense or act committed or done or any penalty of forfeiture incurred or any contract established or accruing between the first day of May, 1953, and the twenty-seventh day of July, 1960; nor shall it affect any prosecution, suit or proceeding pending or any judgment rendered between the first day of May, 1953, and the twenty-seventh day of July, 1960; nor shall such repeal affect any ordinance or resolution promising or guaranteeing the payment of money for the City or authorizing the issue of any bonds of the City or any evidence of indebtedness of the City or any contract or obligation assumed by the City; nor shall such repeal affect the administrative ordinances of the City Council not in conflict or inconsistent with the provisions of the Supplement adopted by this Ordinance; nor shall it affect any right or franchise conferred by any ordinance of the City Council on any person, firm or corporation; nor shall it affect any of the following ordinances:

- (a) Any appropriation ordinances;
- (b) Any ordinance levying and imposing taxes not contained in the Code;
- (c) Any ordinance relative to the opening, relocation and closing of streets and alleys;
- (d) Any ordinance relative to building setback lines;
- (e) Any ordinance authorizing encroachment on streets and sidewalks;
- (f) Any ordinance establishing or changing voting places or voting precincts in the City;

- (g) Any ordinance relative to the division of the City into school districts or relative to boundaries of school districts;
- (h) The Building Code of the City, as amended;
- (i) Any ordinance establishing a community unit plan;
- (j) Any ordinance amending a zoning map;
- (k) Any ordinance amending the master plan or highway plan of the City;
- (l) Any ordinance passed after July 26, 1960.

Section 4. That a copy of the "1960 Cumulative Supplement of The Code of the City of Alexandria, Virginia, 1953", bearing the manual signatures of the Mayor and City Clerk, be filed in the office of the City Clerk and be made available to any person desiring to examine the same.

Section 5. That 300 copies of the "1960 Cumulative Supplement of The Code of the City of Alexandria, Virginia, 1953", shall be printed by the Michie City Publications Company, Charlottesville, Virginia, under the direction of the City Attorney. The signatures of the Mayor and the City Clerk shall be printed on the title page of said copies, without facsimile reproduction, in the following manner:

Section 6. That this Ordinance shall be published in a newspaper of general circulation in the City not later than five days following its introduction together with a notice containing the time and place for a public hearing. The Clerk of the Council shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This Ordinance shall become effective the date of its final passage.
