

Ordinance No. 1173

AN ORDINANCE to amend the Master Plan of the City of Alexandria, Virginia, as amended, by adding thereto an amended major thoroughfare plan, as shown on a map entitled "MAJOR THOROUGHFARE PLAN, CITY OF ALEXANDRIA, VIRGINIA," dated February 1962 and amended June 1962, together with a report entitled "REPORT OF THE MAJOR THOROUGHFARE PLAN OF THE CITY OF ALEXANDRIA, VIRGINIA, FEBRUARY 1962," and amended June 1962.

WHEREAS, an amended major thoroughfare plan for the City as shown on a map entitled "MAJOR THOROUGHFARE PLAN, CITY OF ALEXANDRIA, VIRGINIA," dated February 1962, together with a report entitled "REPORT OF THE MAJOR THOROUGHFARE PLAN OF THE CITY OF ALEXANDRIA, VIRGINIA, FEBRUARY 1962," was duly adopted as a part of the Master Plan of the City of Alexandria, Virginia, by a resolution of the City Planning Commission on April 3, 1962, which resolution with said plan and report attached was duly certified to the City Council; and

WHEREAS, the City Council has conducted further hearings on the above-mentioned plan and report and wishes to adopt them amended in accordance with a report of a special Council committee dated June 19, 1962; therefore

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That a major thoroughfare plan for the City of Alexandria, Virginia, shown on a map entitled "MAJOR THOROUGHFARE PLAN, CITY OF ALEXANDRIA, VIRGINIA," dated February 1962 as amended in accordance with a report of a special Council committee dated June 19, 1962, together with a report entitled "REPORT OF THE MAJOR THOROUGHFARE PLAN OF THE CITY OF ALEXANDRIA, VIRGINIA, FEBRUARY 1962," as amended in accordance with a report of a special Council committee dated June 19, 1962, be and the same hereby is approved and adopted as a part of the Master Plan of the City of Alexandria, Virginia.

Section 2. That the Master Plan of the City of Alexandria, Virginia, with all amendments, additions and extensions thereto, be and the same hereby is amended by adding thereto a major thoroughfare plan for the City of Alexandria, Virginia, shown on a map entitled "MAJOR THOROUGHFARE PLAN, CITY OF ALEXANDRIA, VIRGINIA," dated February 1962, as amended in accordance with a report of a special

Council committee dated June 19, 1962, together with a report entitled "REPORT ON THE MAJOR THOROUGHFARE PLAN OF THE CITY OF ALEXANDRIA, VIRGINIA, FEBRUARY 1962," as amended in accordance with a report of a special Council committee dated June 19, 1962.

Section 3. That the hereinabove approved and adopted plan and report shall not be deemed to open or establish any street, nor to take any land for street purposes, nor for public use, nor as a public improvement, but solely as a reservation of the street locations shown thereon, for future taking or acquisition for public use.

Section 4. That the plan and report above mentioned shall be signed by the Mayor, attested by the Clerk of the Council and the seal of the City of Alexandria affixed thereto.

Section 5. That the Clerk of the Council shall transmit the said plan and report along with a duly certified copy of this ordinance to the Clerk of the Corporation Court of the City of Alexandria, and shall request the Clerk to file the same among the Court records.

Section 6. That this ordinance shall be published in a newspaper of general circulation in the City not later than five days following its introduction together with a notice containing the time and place for a public hearing. The Clerk of the Council shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
