

# Ordinance No. 1176

AN ORDINANCE appropriating and allotting the proceeds of the sale of \$3,945,000 City of Alexandria, Virginia, Public Improvement Bonds to be used for acquiring an existing building and site for use as additional offices for the City, remodeling said building and acquiring necessary equipment; completing the improvement and construction of City buildings, including the remodeling of a portion of the City Hall and the acquisition of necessary equipment; constructing school buildings and additions to existing school buildings, remodeling existing school buildings, and acquiring necessary land and equipment; constructing, paving, widening and otherwise improving streets, including bridges, viaducts and underpasses and the acquisition of necessary land and rights of way; constructing sanitary sewers; constructing and equipping a fire house and acquiring the necessary land and equipment; constructing off-street parking facilities, including parking lots and garages, and acquiring necessary land and equipment; acquiring recreational facilities comprising parks, playgrounds and recreation centers, including the construction of necessary buildings and structures and the acquisition of necessary land and equipment; completing the construction and equipping of a new public City auditorium and gymnasium.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That the sum of \$3,945,000 be and the same hereby is appropriated for the purposes of acquiring an existing building and site for use as additional offices for the City, remodeling said building and acquiring necessary equipment; completing the improvement and construction of City buildings, including the remodeling of a portion of the City Hall and the acquisition of necessary equipment; constructing school buildings and additions to existing school buildings, remodeling existing school buildings, and acquiring necessary land and equipment; constructing, paving, widening and otherwise improving streets, including bridges, viaducts and underpasses and the acquisition of necessary land and rights of way; constructing sanitary sewers; constructing and equipping a fire house and acquiring the necessary land and equipment; acquiring recreational facilities comprising parks, playgrounds and recreation centers, including the construction of necessary buildings and structures and the acquisition of necessary land and equipment; completing the construction and equipping of a new public City auditorium and gymnasium.

Section 2. That the said sum be and the same hereby is allotted to the following bond accounts of the City of Alexandria, Virginia, in the amounts listed and for the purposes stated:

- (1) The Public Buildings Bond Account to be used for acquiring an existing building and site for use as additional offices for the City, remodeling said building and acquiring necessary equipment ..... \$135,000.00
- (2) The Public Buildings Bond Account to be used for completing the improvement and construction of City buildings, including the remodeling of a portion of the City Hall and the acquisition of necessary equipment ..... \$570,000.00

- (3) The School Building Bond Account to be used for constructing school buildings and additions to existing school buildings, remodeling existing school buildings, and acquiring necessary land and equipment ----- \$862,000.00
- (4) The Street Bond Account to be used for constructing, paving, widening and otherwise improving streets, including bridges, viaducts and underpasses and the acquisition of necessary land and rights of way ----- \$1,234,000.00
- (5) The Sanitary Sewers Bond Account to be used for constructing sanitary sewers ----- \$165,000.00
- (6) The Fire House and Equipment Bond Account to be used for constructing and equipping a fire house and acquiring the necessary land and equipment ----- \$171,000.00
- (7) The Off-Street Parking Facilities Bond Account to be used for constructing off-street parking facilities, including parking lots and garages, and acquiring necessary land and equipment ----- \$200,000.00
- (8) The Public Parks, Playgrounds and Recreational Facilities Bond Account to be used for acquiring recreational facilities comprising parks, playgrounds and recreation centers, including the construction of necessary buildings and structures and the acquisition of necessary land and equipment \$325,000.00
- (9) The Public City Auditorium and Gymnasium Bond Account to be used for completing the construction and equipping of a new public City auditorium and gymnasium. -- \$283,000.00

Section 3. That before any project, calling for the expenditure of the funds appropriated and allotted above, be started, such project must be approved by a majority vote of the Council members present at any lawful meeting of the City Council of Alexandria, Virginia.

Section 4. That before any funds appropriated and allotted above are expended, such expenditure must be approved by a majority vote of the Council members present at any lawful meeting of the City Council of the City of Alexandria, Virginia.

Section 5. That this ordinance shall be published in a newspaper of general circulation in the City not later than five days following its introduction together with a notice containing the time and place for a public hearing. The Clerk of the Council shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective when the proceeds of the sale of \$3,945,000 City of Alexandria, Virginia, Public Improvement Bonds of 1962 are received by the City.
