

Ordinance No. 1236

AN ORDINANCE to amend Sections 32A-1, 32A-2, 32A-3, 32A-6, 32A-7, 32A-8, 32A-12 and 32A-13 of Chapter 32A of The Code of the City of Alexandria, Virginia, 1953, as amended, which Chapter 32A relates to TREES, SHRUBS, PLANTS AND VEGETATION; which Section 32A-1 relates to ADMINISTRATION, which Section 32A-2 relates to PERMIT TO PLANT TREES, SHRUBS, PLANTS AND VEGETATION IN PUBLIC PLACES REQUIRED; which Section 32A-3 relates to ISSUANCE OF PERMIT; which Section 32A-6 relates to MASTER PLAN; which Section 32A-7 relates to DIRECTOR OF PUBLIC WORKS. CARE OF TREES, SHRUBS, PLANTS, AND VEGETATION; which Section 32A-8 relates to RESTRICTIONS ON REMOVAL OF TREES, SHRUBS, PLANTS AND VEGETATION FROM PUBLIC PROPERTY BY DIRECTOR OF PUBLIC WORKS; which Section 32A-12 relates to FINAL ACTION UPON FAILURE TO COMPLY WITH Sec. 32A-9; and which Section 32A-13 relates to IMMEDIATE DANGER FROM TREES, SHRUBS, PLANTS, OR OTHER VEGETATION ON PRIVATE PROPERTY.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Section 32A-1 of Chapter 32A of The Code of the City of Alexandria, Virginia, 1953, as amended, be and the same hereby is amended by deleting therefrom the words "Public Works" wherever they appear and inserting and substituting in their place the words "Parks and Recreation."

Section 2. That Section 32A-2 of Chapter 32A of The Code of the City of Alexandria, Virginia, 1953, as amended, be and the same hereby is amended by deleting therefrom the words "Public Works" wherever they appear and inserting and substituting in their place the words "Parks and Recreation."

Section 3. That Section 32A-3 of Chapter 32A of The Code of the City of Alexandria, Virginia, 1953, as amended, be and the same hereby is amended by deleting therefrom the words "Public Works" wherever they appear and inserting and substituting in their place the words "Parks and Recreation."

Section 4. That Section 32A-6 of Chapter 32A of The Code of the City of Alexandria, Virginia, 1953, as amended, be and the same hereby is amended by deleting therefrom the words "Public Works" wherever they appear and inserting and substituting in their place the words "Parks and Recreation."

Section 5. That Section 32A-7 of Chapter 32A of The Code of the City of Alexandria, Virginia, 1953, as amended, be and the same

hereby is amended by deleting therefrom the words "Public Works" wherever they appear and inserting and substituting in their place the words "Parks and Recreation."

Section 6. That Section 32A-8 of Chapter 32A of The Code of the City of Alexandria, Virginia, 1953, as amended, be and the same hereby is amended by deleting therefrom the words "Public Works" wherever they appear and inserting and substituting in their place the words "Parks and Recreation."

Section 7. That Section 32A-12 of Chapter 32A of The Code of the City of Alexandria, Virginia, 1953, as amended, be and the same hereby is amended by deleting therefrom the words "Public Works" wherever they appear and inserting and substituting in their place the words "Parks and Recreation."

Section 8. That Section 32A-13 of Chapter 32A of The Code of the City of Alexandria, Virginia, 1953, as amended, be and the same hereby is amended by deleting therefrom the words "Public Works" wherever they appear and inserting and substituting in their place the words "Parks and Recreation."

Section 9. That this ordinance shall be published in a newspaper of general circulation in the City not later than five days following its introduction together with a notice containing the time and place for a public hearing. The Clerk of the Council shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
