

# Ordinance No. 1250

**AN ORDINANCE adopting a revision and codification of the ordinances of the City of Alexandria, Virginia, providing for the repeal of ordinances not contained therein with certain exceptions and for other purposes hereinafter set forth.**

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That the ordinances of the City of a general and permanent nature as revised in the following chapters, namely Chapters 1 to 42, both inclusive, are hereby ordained as general ordinances of the City of Alexandria, and are adopted as and shall constitute "The Code of the City of Alexandria, Virginia, 1963."

Section 2. That the provisions of such Code shall be in force on and after January 15, 1964, and all provisions of "The Code of the City of Alexandria, Virginia, 1963", and all other ordinances of a general and permanent nature enacted on or prior to July 1, 1963, and not contained in such Code are hereby repealed from and after the said January 15, 1964.

Section 3. That the repeal provided for in the preceding section of this ordinance shall not affect any offense or act committed or done or any penalty or forfeiture incurred on any contract or right established or accruing before January 15, 1964; nor shall it affect any prosecution, suit or proceeding pending or judgment rendered on or prior to January 15, 1964; or shall such repeal affect any ordinance or resolution promising or guaranteeing the payment of money for the City or authorizing the issue of any bonds of the City or any evidence of indebtedness of the City or any contract or obligation assumed by the City; nor shall such repeal affect the administrative ordinances of the City Council not in conflict or inconsistent with the provisions of such Code; nor shall it affect any right or franchise conferred by any ordinance of the City Council on any person, firm or corporation; nor shall it affect any of the following ordinances:

- (a) Any appropriation ordinance;
- (b) Any ordinance levying and imposing taxes not contained in the Code;
- (c) Any ordinance relative to the opening, relocation and closing of streets and alleys;
- (d) Any ordinance authorizing encroachments on streets and sidewalks;
- (e) Ordinance No. 1169, adopting the Building Code of the City, or any amendments thereto;
- (f) Ordinance No. 367 and Ordinance No. 377, relative to civilian defense;
- (g) Ordinance No. 760, relative to the creation of a sanitation authority;
- (h) Any ordinance establishing a community unit plan;
- (i) Any ordinance enacting or amending a zoning map;
- (j) Any ordinance amending or adopting a master plan, highway plan or major thoroughfare plan for the City;
- (k) Any ordinance passed after July 1, 1963.

Section 4. That a copy of "The Code of the City of Alexandria, Virginia, 1963", bearing the manual signatures of the Mayor and City Clerk, shall be filed in the office of the City Clerk, and shall be made available to persons desiring to examine the same.

Section 5. This ordinance shall become effective the date of its passage.
