

ORDINANCE NO. 1496

AN ORDINANCE to amend and reordain subsections (2) and (3) of subparagraph (f), and subparagraph (h), all of Section 1-17 of Chapter 1 of The Code of the City of Alexandria, Virginia, 1963, as amended; which Chapter 1 relates to GENERAL PROVISIONS; which Section 1-17 relates to ESTABLISHMENT OF ELECTION DISTRICTS AND VOTING PLACES; which subparagraph (f) relates to SIXTH WARD AND ELECTION DISTRICTS AND VOTING PLACES THEREIN; which subsection (2) relates to the MT. VERNON SCHOOL ELECTION DISTRICT AND VOTING PLACE THEREIN; which subsection (3) relates to the CORA KELLY SCHOOL ELECTION DISTRICT AND VOTING PLACE THEREIN, and which subparagraph (h) relates to EIGHTH WARD AND ELECTION DISTRICTS AND VOTING PLACES THEREIN; all of which CHANGES THE BOUNDARIES OF THE MT. VERNON SCHOOL ELECTION DISTRICT, THE CORA KELLY SCHOOL ELECTION DISTRICT AND THE WILLIAM RAMSAY SCHOOL ELECTION DISTRICT AND ESTABLISHES A NEW JOHN ADAMS MIDDLE SCHOOL ELECTION DISTRICT AND VOTING PLACE.

WHEREAS, the City Council of the City of Alexandria, Virginia is of the opinion that certain improvements should be made in the designation of some election districts and voting places in the city prior to the forthcoming Presidential election; and

WHEREAS, notices of changes proposed have been posted; therefore

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That subsections (2) and (3) of subparagraph (f) of Section 1-17, Chapter 1 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby are amended and reordained to read as follows:

(2) The Mt. Vernon School Election District shall be bounded and described as follows:

Beginning at the center line of the intersection of Mt. Ida Avenue and Russell Road; thence northward along the center line of Russell Road to the center line of Mt. Vernon Avenue; thence southward along the center line of Mt. Vernon Avenue to the center line of Reed Avenue; thence eastward along the center line of Reed Avenue to the center line of Commonwealth Avenue; thence southward along the center line of Commonwealth Avenue to the center line of * Hume Avenue; thence eastward along the center line of Hume Avenue to the center line of Jefferson Davis Highway; thence southward along the center line of Jefferson Davis Highway to the center line of Mt. Ida Avenue; thence * westward along the center line of * Mt. Ida Avenue to the center line of Uhler Avenue; thence westward along the center line of Uhler Avenue to the center line of Clyde Avenue; thence northward along the center line of Clyde Avenue to the center line of Mt. Ida Avenue; thence westward along the center line of Mt. Ida Avenue to the point of beginning.

The voting place within the Mt. Vernon School Election District shall be at the Mt. Vernon School located at the west side of Mt. Vernon Avenue, between Uhler Avenue and Randolph Street.

(3) The Cora Kelly School Election District shall be bounded and described as follows:

Beginning at the center line of the intersection of * Mt. Vernon Avenue and Hume Avenue; * thence northward along the center line of Commonwealth Avenue to the center line of Reed Avenue; thence westward along the center line of Reed Avenue to the center line of Mt. Vernon Avenue; thence northward along the center line of Mt. Vernon Avenue to the northern city boundary; thence eastward along such boundary to the center line of Jefferson Davis Highway; thence southward along the center line of Jefferson Davis Highway to the center line of * Hume Avenue; * thence westward along the center line of * Hume Avenue to the point of beginning.

The voting place within the Cora Kelly School Election District shall be at the Cora Kelly School, located at the northwest corner of the intersection of Reed Avenue and Commonwealth Avenue.

Section 2. That subparagraph (h) of Section 1-17, Chapter 1 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended and reordained to read as follows:

(h) Eighth Ward. St. James Methodist Church Election District and voting place; William Ramsay School Election District and voting place; John Adams Middle School Election District and voting place.

(1) The St. James Methodist Church Election District shall be bounded and described as follows:

Beginning at the point of intersection of the center line of the Henry G. Shirley Memorial Highway and Seminary Road; thence northward along the center line of the Henry G. Shirley Memorial Highway to the Arlington County line; thence westerly along the Arlington County line to the western boundary of the city; thence southward along the western boundary of the city to the center line of Seminary Road; thence eastward along the center line of Seminary Road to the point of beginning.

The voting place within the St. James Methodist Church Voting District shall be the St. James Methodist Church, located at 5000 Echols Avenue.

(2) The William Ramsay School Election District shall be bounded and described as follows:

Beginning at the point of intersection of the center line of the Henry G. Shirley Memorial Highway with the western boundary of the city; thence northward along the western boundary of the city to the center line of * Holmes Run; thence southward along the center line of Holmes Run to the intersection of the north property line of the William Ramsay School property site; thence eastward along the north property line to the center line of Sanger Avenue; thence eastward along the center line of * Sanger Avenue to the center line of Henry G. Shirley Memorial Highway; thence southward along the center line of

the Henry G. Shirley Memorial Highway to the point of beginning.

The voting place within the William Ramsay School Election District shall be at the William Ramsay School, located at 5700 Sanger Avenue.

(3) The John Adams Middle School Election District shall be bounded and described as follows:

Beginning at the point of intersection of the center line of the Henry G. Shirley Memorial Highway and Seminary Road; thence westerly along the center line of Seminary Road to the western boundary of the city; thence westerly along the present boundary line to the intersection of Holmes Run; thence southward along the center line of Holmes Run to the intersection of the north property line of the William Ramsay School property site; thence eastward along the north property line to the center line of Sanger Avenue; thence eastward along the center line of Sanger Avenue to the center line of the Henry G. Shirley Memorial Highway; thence northward along the center line of the Henry G. Shirley Memorial Highway to the point of beginning.

The voting place within the John Adams Middle School Election District shall be at the John Adams Middle School on Rayburn Avenue.

Section 3. That upon the passage of this ordinance the Director of the Department of General Services shall cause copies of this ordinance to be posted at the front door of the Courthouse and at each voting place in each election district affected, for a period of at least thirty (30) days prior to the next election.

Section 4. That this ordinance shall be published in a newspaper of general circulation in the City not later than five days following its introduction together with a notice containing the time and place for a public hearing. The Clerk of the Council shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
