

AN ORDINANCE to amend Division 1, Article IV by adding thereto a new section numbered 22-115.1, to amend Division I, Article V by adding thereto a new section numbered 22-137.2, and to amend Division 2, Article V by adding thereto a new section numbered 22-152.2, all of Chapter 22 of The Code of the City of Alexandria, Virginia, 1963, as amended; which Chapter 22 relates to MOTOR VEHICLES AND TRAFFIC, which Article IV relates to STOPPING, STANDING AND PARKING GENERALLY, which Division 1 relates to IN GENERAL, which Article V relates to PARKING METERS, which Division 1 relates to ON STREETS, which Division 2 relates to METERED PARKING LOTS, and which new sections 22-115.1, 22-137.2 and 22-152.2 relate to CONDITIONS PRECEDENT TO ISSUANCE OF WARRANT FOR VIOLATION OF PARKING PROVISIONS.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Division 1, Article IV of Chapter 22 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by adding thereto a new section numbered 22-115.1 to read as follows:

Sec. 22-115.1. Conditions precedent to issuance of warrant for violation of parking provisions.

Before any warrant shall issue for the prosecution of a violation under this division, the violator shall have first been notified by registered mail at his last known address or at the address shown for such violator on the records of the Division of Motor Vehicles, that he may pay the fine, provided by law for such violation, within five days of receipt of such notice, and the officer issuing such warrant shall be notified that the violator has failed to pay such fine within such time.

Section 2. That Division 1, Article V of Chapter 22 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by adding thereto a new section numbered 22-137.2 to read as follows:

Sec. 22-137.2. Conditions precedent to issuance of warrant for violation of parking provisions.

Before any warrant shall issue for the prosecution of a violation under this division, the violator shall have first been notified by registered mail at his last known address or at the address shown for such violator on the records of the Division of Motor Vehicles, that he may pay the fine, provided by law for such violation, within five days of receipt of such notice, and the officer issuing such warrant shall be notified that the violator has failed to pay such fine within such time.

Section 3. That Division 2, Article V of Chapter 22 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by adding thereto a new section numbered 22-152.2 to read as follows:

Sec. 22-152.2. Conditions precedent to issuance of warrant for violation of parking provisions.

Before any warrant shall issue for the prosecution of a violation under this division, the violator shall have first been notified by registered mail at his last known address or at the address shown for such violator on the records of the Division of Motor Vehicles, that he may pay the fine, provided by law for such violation, within five days of receipt of such notice, and the officer issuing such warrant shall be notified that the violator has failed to pay such fine within such time.

Section 4. That this ordinance shall be published in a newspaper of general circulation in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The Clerk of the Council shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
