

ORDINANCE NO. 2448

AN ORDINANCE to amend Section 42-3, Article II, Chapter 42 of The Code of the City of Alexandria, Virginia, 1963, as amended; which Section 42-3 relates to ZONE BOUNDARIES; ADOPTION OF ZONING MAPS, which Article II relates to ZONES AND GENERAL PROVISIONS and which Chapter 42 relates to ZONING.

WHEREAS, pursuant to due and timely notice of the time and place of hearing published in a newspaper of general circulation published in the City of Alexandria, Virginia, by mailing and by posting, a public hearing was held in relation to the matters hereinafter set forth, at which public hearing parties in interest and citizens had an opportunity to be heard; therefore,

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That the "FIFTH REVISED ZONING MAP" described and referred to in Section 42-3, Article II, Chapter 42 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended in the particulars following so that the pieces of property hereinafter listed are changed to the respective zones specified:

- (a) All of Lot 40, Block 4, City of Alexandria Assessment Map 28.00, having frontage on North Beauregard Street of approximately 226 feet and containing 0.16754 acre (7,298 square feet).

FROM: R-12 residence
TO: RT townhouse residence

- (b) All of Lot 1, Block 3, and part of Lot 1, Block 4, City of Alexandria Assessment Map 75.01 and parts of Lots 2 and 3, Block 7, City of Alexandria Assessment Map 65.03, having frontage on North Union Street of approximately 459.89 feet, Cameron Street of approximately 424.89 feet, North Lee Street of approximately 246.13 feet and Fayette Alley of approximately 300.00 feet and containing 2.3164 acres (100,902.38 square feet).

FROM: I-2 industrial
TO: CO commercial office (Mixed use-commercial office pursuant to section 42-19(h) of the City Code)

Section 2. Copies of any matter incorporated in this ordinance by reference, including but not limited to the "FIFTH REVISED ZONING MAP," as amended, and any other map referred to in this ordinance, may be examined in the city hall of the City of Alexandria, Virginia, at the citizens assistance office, room 103, at the city clerk's office, room 302 and at the information desk in the main lobby of the King Street entrance to city hall, and also at the department of planning and community development, room 201, 320 King Street, Alexandria, Virginia 22314, phone 750-6311.

Section 3. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
