

ORDINANCE NO. 2532

AN ORDINANCE to amend and reordain the introductory paragraph and subsection (a), Section 22-121.16, Article IV-A, Chapter 22 of The Code of the City of Alexandria, Virginia, 1963, as amended; which Chapter 22 relates to MOTOR VEHICLES AND TRAF-FIC, which Article IV-A relates to PERMIT PARKING DISTRICTS, which Section 22-121.16 relates to PARKING PERMITS; ISSUANCE, which introductory paragraph relates to APPLICABILITY and which subsection (a) relates to ISSUANCE AND FEES.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Section 22-121.16, Article IV-A, Chapter 22 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended and reordained by amending the introductory paragraph and subsection (a) to read as follows:

The city manager shall, upon payment of the fee provided for by this article, issue permits for the parking of motor vehicles in or adjacent to permit parking districts for more than three (3) consecutive hours as follows:

(a) To persons who reside in a permit parking district, or to persons who reside in dwellings located on blocks adjacent to existing permit parking districts where parking on said blocks is controlled by time limits set by official signs or metered parking and who, in the determination of the city manager, lack any adequate alternative nearby parking which is not controlled by parking meters or official signs which set time limits or prohibit parking, one permit for each vehicle belonging to such person for which the person has paid all personal property taxes imposed thereon by the city and which displays a valid license windshield tag issued pursuant to the provisions of article XII, chapter 22 of the city code. Such permits shall be valid for one (1) year expiring on April thirtieth of each year and shall be renewable no later than May first of each year. Applicants for permits issued pursuant to this subsection shall provide proof of residence and, for each vehicle for which a permit is sought, a motor vehicle registration card issued by the division of motor vehicles and proof of payment of all personal property taxes and license fees imposed thereon by the city. For each permit issued or renewed pursuant to this subsection, there shall be imposed a fee of two dollars (\$2.00) for each of the first two (2) vehicles, and for each additional vehicle the fee shall be ten dollars (\$10.00). Any owner who has been issued a permit for a vehicle pursuant to this subsection may obtain a replacement permit for use on another vehicle registered in such owner's name, upon application on forms furnished by the city manager and

presentation of the registration card for the vehicle for which the replacement permit is sought and pieces of the previously issued permit as proof that it was removed from the vehicle for which the fee was previously paid, accompanied by a fee of one dollar (\$1.00).

Section 2. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
