

ORDINANCE NO. 2553

AN ORDINANCE to amend and reordain the fifth WHEREAS paragraph and Section 7, both of Ordinance No. 2530 of the City of Alexandria, Virginia; which Section 7 relates to TIME FOR COMPLIANCE and which fifth WHEREAS paragraph relates to PURPOSE OF THE CONVERSION.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That the fifth WHEREAS paragraph of Ordinance No. 2530 be and the same hereby is amended and reordained to read as follows:

WHEREAS, Acorn Limited Partnership wishes to buy said Property at the price, terms and conditions recommended for the purpose of converting the existing building to commercial office use and constructing a three- (3) story building; now, therefore,

Section 2. That Section 7 of Ordinance No. 2530 be and the same hereby is amended and reordained to read as follows:

Section 7. That Acorn Limited Partnership must comply in full with all terms and conditions of sale and settle in full by June 1, 1981, all as set out in the aforesaid Agreement of Sale.

Section 3. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
