

ORDINANCE NO. 2569

AN ORDINANCE to amend Sections 20-73, 20-74, 20-75, 20-76, 20-79, 20-81 and 20-82, Article III; and to repeal Section 20-101, Article V, all of Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended; which Chapter 20 relates to LICENSES, which Article III relates to NONREGULATORY LICENSES, which Section 20-73 relates to PROFESSIONAL OCCUPATIONS AND BUSINESSES, which Section 20-74 relates to PERSONAL SERVICES, which Section 20-75 relates to BUSINESS SERVICES AND OCCUPATIONS, which Section 20-76 relates to REPAIR SERVICES AND OCCUPATIONS, which Section 20-79 relates to WHOLESALE MERCHANTS, which Section 20-81 relates to MANUFACTURERS, MILLS AND PROCESSORS SELLING AT RETAIL, which Section 20-82 relates to AMUSEMENTS AND ENTERTAINMENTS, which Article V relates to BUILDERS OR DEVELOPERS and which Section 20-101 relates to PERSONS WHO ARE BOTH CONTRACTORS AND BUILDERS OR DEVELOPERS.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That the first paragraph of Section 20-73, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended and reordained to read as follows:

Every person engaged in one or more of the following professions, occupations or businesses in the city shall pay for the privilege an annual license tax of thirty dollars (\$30.00) and sixty cents (\$0.60) per one hundred dollars (\$100.00) of the gross receipts in excess of five thousand dollars (\$5,000.00) of the one or more professions, occupations or businesses conducted by him, namely:

Section 2. That the list of professional occupations and businesses in Section 20-73, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by adding the following classification at the end of the alphabetical listing:

Other professional occupations or businesses.

Section 3. That Section 20-73, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by deleting the paragraph following the alphabetical listing.

Section 4. That subsections (A) and (B), Section 20-74, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby are amended by

adding the following classification at the end of the alphabetical listings:

Other personal services.

Section 5. That Section 20-74, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by deleting the paragraph following the alphabetical listing in subsection (B).

Section 6. That the list of business services and occupations in Section 20-75, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by adding the following classification at the end of the alphabetical listing:

Other business services or occupations.

Section 7. That Section 20-75, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by deleting the paragraph following the alphabetical listing.

Section 8. That Section 20-76, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by deleting the paragraph following the alphabetical listing.

Section 9. That the list of wholesale merchants in Section 20-79, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by adding to the end of the alphabetical listing the following classification:

Other wholesale merchants.

Section 10. That the list of manufacturers, mills and processors in Section 20-81, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by adding at the end of the alphabetical listing the following classification:

Other manufacturers, mills or processors.

Section 11. That the list of amusements and entertainments in Section 20-82, Article III, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is amended by adding at the end of the alphabetical listing the following classification:

Other amusements or entertainments.

Section 12. That Section 20-101, Article V, Chapter 20 of The Code of the City of Alexandria, Virginia, 1963, as amended, be and the same hereby is repealed.

Section 13. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
