

ORDINANCE NO. 2736

AN ORDINANCE to amend and reordain the title of Chapter 2, Title 1 and to amend and reordain Sections 1-2-1, 1-2-2, 1-2-5 and 1-2-6, all of Chapter 2, Title 1 of The Code of the City of Alexandria, Virginia, 1981, as amended; which Title 1 relates to GENERAL PROVISIONS, which Chapter 2 formerly related to SISTER CITY and now relates to SISTER CITIES, which Section 1-2-1 relates to ESTABLISHED, which Section 1-2-2 formerly related to SISTER CITY COMMITTEE--ESTABLISHED and now relates to SISTER CITIES COMMITTEE--ESTABLISHED, which Section 1-2-5 relates to SAME--POWERS AND DUTIES and which Section 1-2-6 relates to SAME--SECRETARY.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That the title of Chapter 2, Title 1 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

CHAPTER 2.

Sister Cities

Section 2. That Section 1-2-1, Chapter 2, Title 1 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

Sec. 1-2-1. Established.

The cities of Dundee, Scotland, Helsingborg, Sweden and Caen, France are adopted and established as sister cities to Alexandria.

Section 3. That Section 1-2-2, Chapter 2, Title 1 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

Sec. 1-2-2. Sister cities committee--Established.

There is hereby established a committee to be known as the sister cities committee.

Section 4. That Section 1-2-5, Chapter 2, Title 1 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

Sec. 1-2-5. Same--Powers and duties.

It shall be the duty of the committee to:

(a) Plan, develop, encourage and promote an educational and cultural exchange between the cities of Dundee, Scotland, Helsingborg, Sweden, Caen, France and Alexandria.

(b) To coordinate activities within the city relating to such an educational and cultural exchange.

Section 5. That Section 1-2-6, Chapter 2, Title 1 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

Sec. 1-2-6. Same--Secretary.

The city manager shall designate a city employee to serve as secretary to the sister cities committee. The secretary shall not be entitled to vote on the committee.

Section 6. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
