

ORDINANCE NO. 2753

AN ORDINANCE to amend and reordain Section 5-8-72 and subsection (d), Section 5-8-73, Article F, Chapter 8, Title 5 of The Code of the City of Alexandria, Virginia, 1981, as amended; which Title 5 relates to TRANSPORTATION AND ENVIRONMENTAL SERVICES, which Chapter 8 relates to PARKING AND TRAFFIC REGULATIONS, which Article F relates to PERMIT PARKING DISTRICTS, which Section 5-8-72 relates to PARKING IN PERMIT PARKING DISTRICT, which Section 5-8-73 relates to DESIGNATION OF PERMIT PARKING DISTRICTS; NOTICE OF DESIGNATION and which subsection (d) relates to POSTING OF APPROPRIATE SIGNS.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Section 5-8-72, Article F, Chapter 8, Title 5 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

Sec. 5-8-72. Parking in permit parking district.

No person shall park a vehicle on any street except for any block abutted solely by nonresidential property and any portion of a street in which parking is regulated by parking meters or within a permit parking district for more than three (3) consecutive hours or two (2) consecutive hours during the hours of 8:00 a.m. through 5:00 p.m. depending on which time limitation is designated by the sign posted on that block or portion thereof, Monday through Friday, unless the vehicle displays a permit issued for the vehicle as provided by this article or at least one (1) of the license plates, decals or permits enumerated in subsection (a) of section 10-4-19 of this code.

Section 2. That subsection (d), Section 5-8-73, Article F, Chapter 8, Title 5 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

(d) Upon the designation of a permit parking district by the city council, the city manager shall assign a number to that district and shall cause to be posted in each block, or portion thereof in which the provisions of section 5-8-72 are applicable, within the district appropriate signs which shall state thereon one (1) of the following:

Three Hour Parking  
8 a.m. through 5 p.m.  
Monday through Friday  
Except Holders of District \_\_\_\_\_ Permits

Two Hour Parking  
8 a.m. through 5 p.m.  
Monday through Friday  
Except Holders of District \_\_\_\_\_ Permits

In addition to the language above set forth, there shall be affixed to each sign following the word "District" the number assigned by the city manager to the permit parking district in which the sign is located.

Section 3. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
