

ORDINANCE NO. 2888

AN ORDINANCE to amend and reordain Section 10-1-19, Chapter 1 and Section 10-4-34, Chapter 4; to repeal subsection (g), Section 10-3-2 and subsection (b), Section 10-3-7, Chapter 3, to repeal Sections 10-4-12 and 10-4-31, Chapter 4, to repeal Section 10-5-3, Chapter 5 and to repeal Section 10-7-12, Chapter 7; all of Title 10 of The Code of the City of Alexandria, Virginia, 1981, as amended; which Title 10 relates to MOTOR VEHICLES AND TRAFFIC, which Chapter 7 relates to BICYCLES, which Chapter 5 relates to PROTECTION OF PEDESTRIANS, which Chapter 4 relates to STOPPING, STANDING AND PARKING, which Chapter 3 relates to OPERATION OF VEHICLES, which Chapter 1 relates to GENERAL PROVISIONS, which Section 10-7-12 relates to PENALTY FOR VIOLATION OF CHAPTER, which Section 10-5-3 relates to PENALTY FOR VIOLATION OF SECTIONS 10-5-1 and 10-5-2, which Section 10-4-34 relates to UNLAWFUL PARKING IN PERMIT PARKING DISTRICT, which Section 10-4-12 relates to PARKING OF VEHICLES ON PRIVATE PROPERTY, which Section 10-4-31 relates to PENALTY FOR VIOLATION OF CHAPTER, which Section 10-3-7 relates to DRIVING ON SIDEWALKS, which subsection (b) relates to PENALTY, which Section 10-3-2 relates to COMMUTER BUS LANES, which subsection (g) relates to PENALTY and which Section 10-1-19 relates to PENALTIES.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Section 10-1-19, Chapter 1, Title 10 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

Sec. 10-1-19. Penalties.

Every person convicted of violating any of the provisions of this title, for which no other penalty is provided, shall be guilty of a class 4 misdemeanor.

Section 2. That Section 10-4-34, Chapter 4, Title 10 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

Sec. 10-4-34. Unlawful parking in permit parking district.

It shall be unlawful to park a vehicle in a permit parking district in violation of article F, chapter 8, title 5 of this code (section 5-8-71, et seq.).

Section 3. That subsection (g), Section 10-3-2 and subsection (b), Section 10-3-7, Chapter 3; Sections 10-4-12 and 10-4-31, Chapter 4; Section 10-5-3, Chapter 5; and Section

10-7-12, Chapter 7; all of Title 10 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby are repealed.

Section 4. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
