

ORDINANCE NO. 2890

AN ORDINANCE to amend and reordain Sections 9-12-43, 9-12-55 and 9-12-56, all of Division 3, Article A, Chapter 12, Title 9 of The Code of the City of Alexandria, Virginia, 1981, as amended; which Title 9 relates to LICENSING AND REGULATION, which Chapter 12 relates to TAXICABS AND OTHER VEHICLES FOR HIRE, which Article A relates to TAXICABS AND FOR-HIRE VEHICLES, which Division 3 relates to DRIVER'S PERMIT, which Section 9-12-43 relates to CHARGES FOR PERMIT, which Section 9-12-55 relates to EXPIRATION OF PERMIT and which Section 9-12-56 relates to RENEWAL OF PERMIT.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Section 9-12-43, Division 3, Article A, Chapter 12, Title 9 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

Sec. 9-12-43. Charges for permit.

(a) The following charges shall be paid to the director of finance before any initial application for a permit under this division will be considered:

For any application, granted or not.....\$15.00
For fingerprinting.....5.00

(b) The following charge shall be paid to the director of finance before any initial permit is issued.....15.00

(c) The following charge shall be paid to the director of finance before any renewal permit is issued.....25.00

(d) The following charge shall be paid to the director of finance for any duplicate permit.....10.00

(e) The following charges shall be paid to the hack inspector for laminating each initial, renewal or duplicate permit.....5.00.

Section 2. That Section 9-12-55, Division 3, Article A, Chapter 12, Title 9 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

Sec. 9-12-55. Expiration of permit.

All driver's permits issued under this division, except temporary driver's permits issued pursuant to section 9-12-48 of this code, shall expire two (2) years from the date of issuance of the driver's permit, unless sooner suspended or revoked.

Section 3. That Section 9-12-56, Division 3, Article A, Chapter 12, Title 9 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

Sec. 9-12-56. Renewal of permit.

Renewals of driver's permits may be made, provided the applicant follows the procedure set forth for original applications. The renewed permit shall expire two (2) years from the date of issuance.

Section 4. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
