

ORDINANCE NO. 3073

AN ORDINANCE to amend and reordain subsection (a) of Section 3-2-351, and to amend subsection (a) of Section 3-2-354 by adding two new subsections numbered (31) and (32), all of Article S, Chapter 2, Title 3 of The Code of the City of Alexandria, Virginia, 1981, as amended; which Title 3 relates to FINANCE, TAXATION AND PROCUREMENT, which Chapter 2 relates to TAXATION, which Article S relates to PAYMENT, CONTEST AND ENFORCEMENT OF PARKING CITATIONS, which Section 3-2-354 relates to PENALTIES FOR UNCONTESTED PARKING CITATIONS, which subsection (a) relates to PENALTIES FOR UNCONTESTED PARKING FINES TENDERED WITHIN 30 DAYS, which new subsection (31) relates to FINE FOR PARKING WITHOUT DISPLAY OF CURRENT STATE INSPECTION STICKER OR CURRENT STATE LICENSE PLATE and which new subsection (32) relates to FINE FOR PARKING ILLEGALLY IN TEMPORARY NO PARKING ZONE, which Section 3-2-351 relates to PAYMENT OF UNCONTESTED PARKING CITATIONS and which subsection (a) relates to CERTAIN CODE PROVISIONS FOR WHICH UNCONTESTED VIOLATIONS MAY BE PAID.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That subsection (a), Section 3-2-351, Article S, Chapter 2, Title 3 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

(a) For any parking citation issued pursuant to the provisions of sections 5-8-72, 5-8-114, 10-4-1 to 10-4-18, 10-4-22 to 10-4-25, 10-4-28, 10-4-30, 10-4-33, 10-4-34, 10-4-37, 10-4-38 and 10-4-39 of this code, the amount of the penalty established by section 3-2-354 for the violation for which the citation was issued, when the citation is uncontested, may be paid to the director of finance in lieu of a trial on the charge.

Section 2. That subsection (a), Section 3-2-354, Article S, Chapter 2, Title 3 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended by adding two new subsections numbered (31) and (32) to read as follows:

(31) \$20 for a violation of section 10-4-38, "Parking without display of current state inspection sticker or current state license plate;"

(32) \$20 for a violation of section 10-4-39, "Temporary parking prohibited."

Section 3. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five

days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
