

ORDINANCE NO. 3105

AN ORDINANCE to amend and reordain subsection (10) of subsection (a), and to amend subsection (b) by adding a new subsection (9), all of Section 5-8-92, Division 1; and to amend Section 5-8-112 by adding two new subsections numbered (6) and (7), Division 2, all of Article G, Chapter 8, Title 5 of The Code of the City of Alexandria, Virginia, 1981, as amended; which Title 5 relates to TRANSPORTATION AND ENVIRONMENTAL SERVICES, which Chapter 8 relates to PARKING AND TRAFFIC REGULATIONS, which Article G relates to PARKING METERS, which Division 2 relates to METERED PARKING LOTS, which Division 1 relates to PARKING METER ZONES, which Section 5-8-112 relates to ESTABLISHMENT OF METERED PARKING LOTS, which new subsection (6) relates to SIMPSON STADIUM PARKING LOT, which subsection (7) relates to HOLLAND LANE PARKING LOT, which Section 5-8-92 relates to PARKING METER ZONES ESTABLISHED, which subsection (b) relates to PARKING METER ZONE 2, which new subsection (9) relates to PARKING METERS ON PEYTON STREET, which subsection (a) relates to PARKING METER ZONE 1 and which subsection (10) relates to PARKING METERS ON FAIRFAX STREET.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That subsection (10), subsection (a), Section 5-8-92, Division 1, Article G, Chapter 8, Title 5 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

(10) Both sides of the 100 block of South Fairfax Street, the east side of the 100 block, and both sides of the 900 block of North Fairfax Street.

Section 2. That subsection (b), Section 5-8-92, Division 1, Article G, Chapter 8, Title 5 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended by adding a new subsection (9) to read as follows:

(9) Both sides of the 100 block of South Peyton Street.

Section 3. That Section 5-8-112, Division 2, Article G, Chapter 8, Title 5 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended by adding two new subsections numbered (6) and (7) to read as follows:

(6) All of that parcel of land in the city designated Municipal Parking Lot No. 6, located at the intersection of the north side of Monroe Avenue and the east side of Leslie Avenue.

(7) All of that parcel of land in the city designated Municipal Parking Lot No. 7, located on the west side of Holland Lane between Duke Street and the Southern Railway.

Section 4. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
