

ORDINANCE NO. 3149

AN ORDINANCE to amend and reordain subsection (e), Section 2-2-10, Chapter 2, Title 2 of The Code of the City of Alexandria, Virginia, 1981, as amended; which Title 2 relates to GENERAL GOVERNMENT, which Chapter 2 relates to ELECTIONS, which Section 2-2-10 relates to ESTABLISHMENT OF ELECTION DISTRICTS AND VOTING PLACES and which subsection (e) relates to FIFTH WARD.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That subsection (e), Section 2-2-10, Chapter 2, Title 2 of The Code of the City of Alexandria, Virginia, 1981, as amended, be and the same hereby is amended and reordained to read as follows:

(e) Fifth Ward. Maury School Election District and voting place; Fair-Park Baptist Church Election District and voting place; Chinguapin Election District and voting place; George Washington School Election District and voting place; and Immanuel Lutheran Church Election District and voting place.

The fifth ward shall be divided into the Maury School Election District, the Fair-Park Baptist Church Election District, the Chinguapin Election District, the George Washington School Election District and the Immanuel Lutheran Church Election District.

(1) The Maury School Election District shall be bounded and described as follows:

Beginning at the centerline of the intersection of King Street and the western right-of-way line of the Richmond, Fredericksburg and Potomac Railroad; thence northward along such right-of-way line to the centerline of Commonwealth Avenue; thence northward along the centerline of Commonwealth Avenue to the centerline of Braddock Road; thence westward along the centerline of Braddock Road to the centerline of Alexandria Avenue; thence southward along the centerline of Alexandria Avenue to the centerline of Timber Branch Parkway; thence southward on a line from the centerline of Alexandria Avenue to the centerline of King Street, such line being perpendicular to King Street; thence eastward along the centerline of King Street to the point of beginning.

The voting place within the Maury School Election District shall be at the Maury School, located on the west side of Russell Road between Rucker Place and Walnut Place.

(2) The Fair-Park Baptist Church Election District shall be bounded and described as follows:

Beginning at the centerline of the intersection of Braddock Road and Radford Street; thence northward along the

centerline of Radford Street to the centerline of Quaker Lane; thence northward along the centerline of Quaker Lane to the centerline of Crestwood Drive; thence eastward along the centerline of Crestwood Drive to the centerline of Valley Drive; thence northward along the centerline of Valley Drive to the centerline of Beverley Drive; thence eastward along the centerline of Beverley Drive to the centerline of Wellington Road; thence northward along the centerline of Wellington Road to the centerline of Beverley Drive; thence eastward along the centerline of Beverley Drive to the centerline of Cameron Mills Road; thence southward along the centerline of Cameron Mills Road to the centerline of Braddock Road; thence westward along the centerline of Braddock Road to the point of beginning.

The voting place within the Fair-Park Baptist Church Election District shall be the Fair-Park Baptist Church, located at 1801 North Quaker Lane.

(3) The Chinguapin Election District shall be bounded and described as follows:

Beginning at the centerline of the intersection of King Street and Radford Street; thence northward along the centerline of Radford Street to the centerline of Braddock Road; thence eastward along the centerline of Braddock Road to the centerline of Alexandria Avenue; thence southward along the centerline of Alexandria Avenue to the centerline of Timber Branch Parkway; thence southward along a line from the centerline of Alexandria Avenue to the centerline of King Street, such line being perpendicular to King Street; thence westward along the centerline of King Street to the point of beginning.

The voting place within the Chinguapin Election District shall be the Chinguapin Park Recreation Center, 3210 King Street.

(4) The George Washington School Election District shall be bounded and described as follows:

Beginning at the centerline of the intersection of Alexandria Avenue and Russell Road; thence eastward along the centerline of Alexandria Avenue to the western right-of-way line of the Richmond, Fredericksburg and Potomac Railroad; thence southward along such right-of-way line to the centerline of Commonwealth Avenue; thence northward along the centerline of Commonwealth Avenue to the centerline of Braddock Road; thence westward along the centerline of Braddock Road to the centerline of Russell Road; thence northward along the centerline of Russell Road to the point of beginning.

The voting place within the George Washington School Election District shall be at the George Washington School, located on the east side of Mount Vernon Avenue between Glendale Avenue and Braddock Road.

(5) The Immanuel Lutheran Church Election District shall be bounded and described as follows:

Beginning at the centerline of the intersection of Alexandria Avenue and Russell Road; thence eastward along the centerline of Alexandria Avenue to the western right-of-way line of the Richmond, Fredericksburg and Potomac Railroad; thence northward along such right-of-way line to the centerline of Monroe Avenue; thence northward along the centerline of Jefferson Davis Highway to the centerline of Bellefonte Avenue; thence westward along the centerline of Bellefonte Avenue to the centerline of Russell Road; thence westward along the centerline of Lloyd's Lane to the centerline of Braddock Road; thence eastward along the centerline of Braddock Road to the point of beginning.

The voting place within the Immanuel Lutheran Church Election District shall be the Immanuel Lutheran Church, 1801 Russell Road.

Section 2. That the title of and an informal memorandum explaining this ordinance shall be published in a newspaper of general circulation published in the city not later than five days following its introduction together with a notice containing the time and place for a public hearing. The city clerk shall have the full text of this ordinance printed in sufficient numbers to supply copies to meet request. The city clerk shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
