

ORDINANCE NO. 3752

AN EMERGENCY ORDINANCE to amend and reordain subsection (k) of Section 2-2-10 (ESTABLISHMENT OF ELECTION DISTRICTS AND VOTING PLACES), of Chapter 2 (ELECTIONS), Title 2 (GENERAL GOVERNMENT) of The Code of the City of Alexandria, Virginia, 1981, as amended.

WHEREAS, the City Council of the City of Alexandria finds and determines that:

1. The voting place established by law within the Agudas Achim Congregation Election District (i.e. the Agudas Achim Congregation, 2908 Valley Drive, Alexandria, Virginia) is under renovation and has been closed to the public for an indeterminate period of time;

2. It is necessary to designate, in the manner provided by law, a new voting place for temporary use within the Agudas Achim Congregation Election District, and to obtain preclearance from the Attorney General of the United States under Section 5 of the Voting Rights Act, in order to implement such change in time for the November 8, 1994, general election;

3. The September 27, 1994, meeting is the next available meeting of City Council at which an ordinance implementing such change can be finally passed, and forwarded for expedited preclearance; and

4. An emergency exists, as contemplated by Section 3.12 of the City Charter; now, therefore,

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That subsection (k) of Section 2-2-10 of The Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to read as follows:

(k) The Agudas Achim Congregation Election District shall be bounded and described as follows:

Beginning at the centerline of the intersection of Beverley Drive and Cameron Mills Road; thence westward along the centerline of Beverley Drive to the centerline of Wellington Road; thence southward along the centerline of Wellington Road to the centerline of Beverley Drive; thence westward along the centerline of Beverley Drive to the centerline of Valley Drive; thence southward along the centerline of Valley Drive to the centerline of Crestwood Drive; thence westward along the centerline of Crestwood Drive to the western city boundary at Quaker Lane; thence northward along the western city boundary

to the northern city boundary at Four Mile Run; thence eastward along the northern city boundary to its intersection with a point due north of the centerline of Cameron Mills Road; thence southward along the centerline of Cameron Mills Road to the point of beginning.

The voting place within the Agudas Achim Congregation Election District shall be at the Parkfairfax Condominium Meeting Room, 3360 Gunston Road.

Section 2. That this ordinance shall become effective upon the date and at the time of its final passage.
