

ORDINANCE NO. 3753

AN ORDINANCE to amend and reordain Section 4-100 (CL/COMMERCIAL SERVICE LOAD ZONE), Section 4-200 (CC/COMMERCIAL COMMUNITY ZONE), Section 4-300 (CSL/COMMERCIAL SERVICE LOAD ZONE), Section 4-400 (CG/COMMERCIAL GENERAL ZONE), Section 4-500 (CD/COMMERCIAL DOWNTOWN ZONE), Section 4-600 (CD-X/COMMERCIAL DOWNTOWN ZONE (OLD TOWN NORTH)), Section 4-800 (OC/OFFICE COMMERCIAL ZONE), Section 4-900 (OCM(50)/OFFICE COMMERCIAL MEDIUM(50) ZONE), Section 4-1000 (OCM(100)/OFFICE COMMERCIAL MEDIUM(100) ZONE), Section 4-1100 (OCH/OFFICE COMMERCIAL HIGH ZONE), of Article IV (COMMERCIAL OFFICE AND INDUSTRIAL ZONES); Section 5-100 (CRMU-L/COMMERCIAL RESIDENTIAL MIXED USE LOW ZONE), Section 5-200 (CRMU-M/COMMERCIAL RESIDENTIAL MIXED USE MEDIUM ZONE), Section 5-300 (CRMU-H/COMMERCIAL RESIDENTIAL MIXED HIGH ZONE), Section 5-400 (CRMU-X/COMMERCIAL RESIDENTIAL USE (OLD TOWN NORTH) Zone), and Section 5-500 (W-1/WATERFRONT MIXED USE ZONE), of Article V (MIXED USE ZONES); and Section 6-100 (POS/PUBLIC OPEN SPACE AND COMMUNITY RECREATION ZONE) and Section 6-200 (WPR/WATERFRONT PARK AND RECREATION ZONE), of Article VI (SPECIAL AND OVERLAY ZONES); all of the City of Alexandria Zoning Ordinance, to permit, by special use permit, outdoor food and craft markets in the said zones.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Sections 4-103, 4-203, 4-303, 4-403, 4-503, 4-603, 4-803, 4-903, 4-1003, 4-1103, 5-103, 5-203, 5-303, 5-403, 5-503, 6-105, and 6-203 of the City of Alexandria Zoning Ordinance be, and the same hereby are, amended to add thereto the following special use permit use, the appropriate subsection designation thereof to be determined by the city attorney in the codification of this ordinance:

( ) Outdoor food and crafts market.

Section 2. That Sections 4-200, 4-300, 4-400, 4-500, 4-600, 4-800, 4-900, 4-1000, 4-1100, 5-100, 5-200, 5-300, 5-400, 5-500, 6-100 and 6-200 of the City of Alexandria Zoning Ordinance, as amended by section 1, be, and the same hereby are, reordained as part of the City of Alexandria Zoning Ordinance.

Section 3. This ordinance shall become effective upon the date and at the time of its final passage.
