

RESOLUTION NO. 368

WHEREAS, the Federal government advised the City of Alexandria last fall that it had declared as surplus a portion of Cameron Station; and

WHEREAS, the two surplus parcels are available to the City at no cost for utilization for public purposes; and

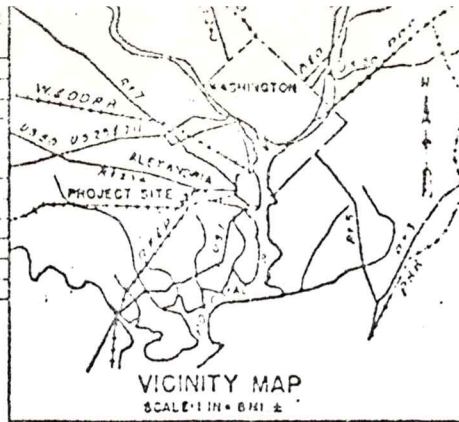
WHEREAS, both parcels would be desirable additions to the City's parklands inventory and would serve neighborhoods which need additional open space areas.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Alexandria, Virginia hereby requests that the Federal government, through the Department of the Interior, Bureau of Outdoor Recreation, transfer to the City of Alexandria the surplus portion of Cameron Station.

FURTHER RESOLVED that these two surplus parcels will be utilized by the City of Alexandria as public parklands.

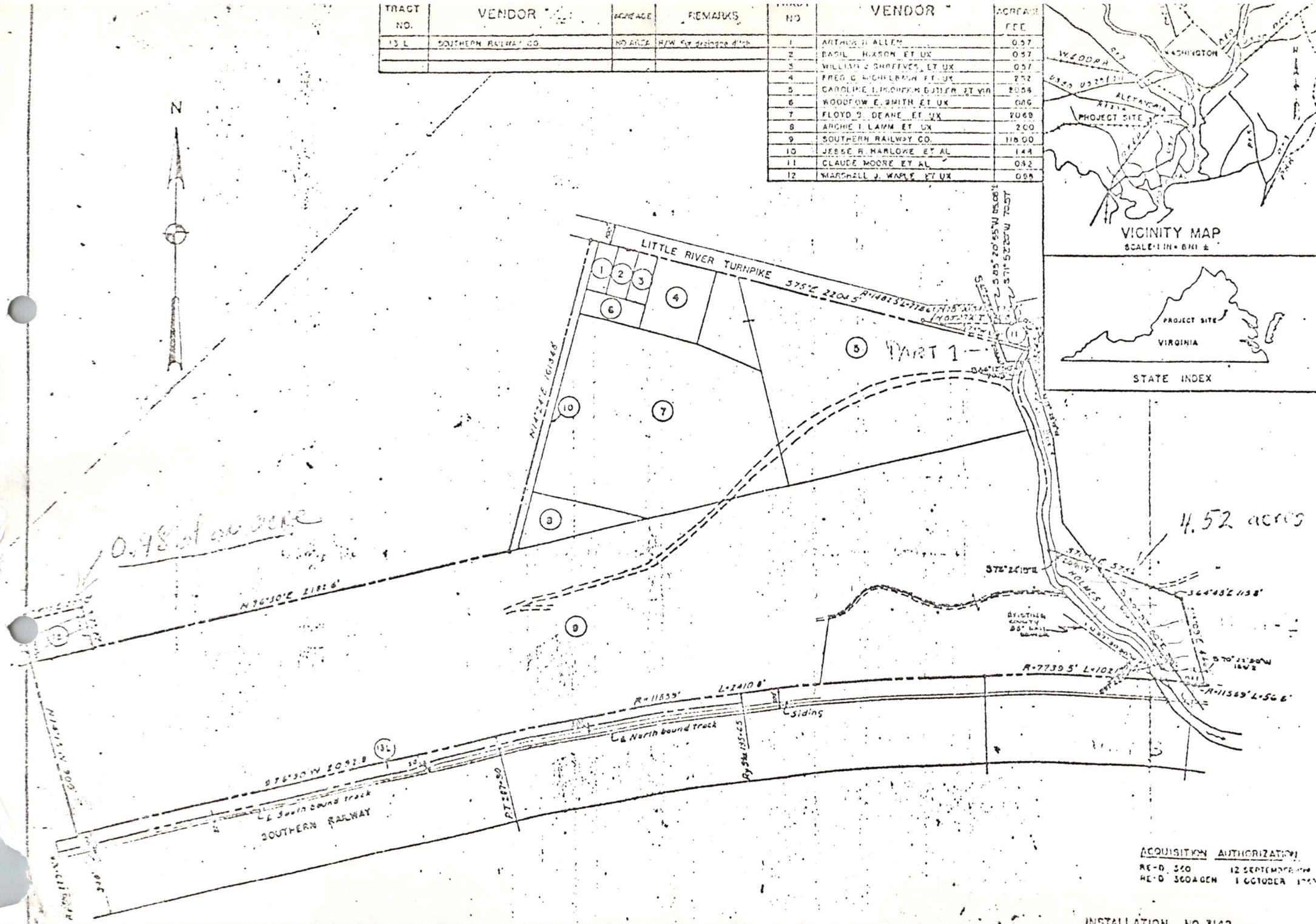
