

RESOLUTION NO. 377

1. Portion of Cameron Station, Alexandria, Virginia.
2. D-VA-649.
3. 4.52 Acres Eastern Parcel, and 0.98 Western Parcel.  
Total Acreage is 5.50.

Whereas, City of Alexandria, needs and will utilize said property in
