

ORDINANCE NO. 232

AN ORDINANCE to require the Alexandria Gas Company and the Alexandria Water Company, both public service corporations organized and doing business under the laws of the State of Virginia, to install their respective mains and necessary appurtenances thereto in Braddock Road from Russell Road to West Street and West Street from Braddock Road to Oronoco Street and to require the owners of all existing houses and vacant lots fronting on either side of Braddock Road and West Street to provide for service connections into said mains of the Alexandria Gas Company and the Alexandria Water Company when so installed from said mains to their respective lot lines; and to prohibit the issuance of any permit for the installation of any water or gas main or appurtenances thereto or for any connecting service line for any house or lot fronting on either side of said Braddock Road and West Street within three (3) years after the construction of the new hard surface of said road and street.

WHEREAS it is the desire and purpose of the Council of the City of Alexandria, Virginia, to improve Braddock Road from Russell Road to West Street and West Street from Braddock Road to Oronoco Street with a new thirty-eight (38) foot width hard-surfaced concrete and macadam surface and to this end the Council of the City of Alexandria has heretofore appropriated the sum of \$50,000 to cover the cost of said proposed improvement and,

WHEREAS it is the desire and purpose of the City of Alexandria to prevent the damage of said new hard surface on said road and street by cuts made therein incident to the installation of gas and water service lines and mains for properties fronting on either side of said road and street for a period of three years after the completion of said road and street,

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Alexandria, Virginia:

SECTION 1.—That the Alexandria Gas Company and the Alexandria Water Company, both public service corporations organized and doing business under the laws of the State of Virginia, shall within thirty (30) days of the receipt of written notice from the City Manager of the City of Alexandria commence and complete the installation of gas and water mains and necessary appurtenances thereto in the right-of-way of said Braddock Road from Russell Road to West Street and West Street from Braddock Road to Oronoco Street.

SECTION 2.—That all property owners having property fronting on either side of said Braddock Road from Russell Road to West Street and West Street from Braddock Road to Oronoco Street shall within forty-five (45) days from the receipt of written notice from the City Manager of the City of Alexandria, Virginia, have provided necessary connections for their properties with the said mains of Alexandria Gas Company and the Alexandria Water Company from said mains to their respective lot lines.

SECTION 3.—That no permit shall be issued by the City of Alexandria, Virginia, through any of its authorized officials for the installation of any gas or water main or for any service connection into such mains within three years after the construction of said proposed new hard surface on Braddock Road and West Street.

SECTION 4.—This ordinance shall take effect immediately upon its passage.
