

ORDINANCE No. 355

AN ORDINANCE to change the names of certain streets in Alexandria, Virginia.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALEXANDRIA, VIRGINIA:

Section 1. That the name of a certain street now known as Cedar Street, east from Seminary Road in West Braddock Heights, be changed to Peach Street.

Section 2. That the name of a certain street now known as Diagonal Avenue, between Valley Drive and Summit Avenue in Braddock Heights, be changed to Fordham Road.

Section 3. That the name of a certain street now known as Hillside Drive, west from Russell Road and parallel with Russell Road to northerly turn, be changed to Mount Drive.

Section 4. That the name of a certain street now known as Hillside Drive, extending east from northerly turn and across Russell Road, be changed to Aspen Street.

Section 5. That the name of a certain street now known as Jackson Avenue, between Mt. Vernon Avenue and Seventh Street, be changed to Adams Avenue.

Section 6. That the name of a certain street now known as Linden Avenue, between Russell Road and the R. F. and P. R. R. right of way, be changed to Nelson Avenue.

Section 7. That the name of a certain street now known as Madison Avenue, north of Virginia Avenue in Jefferson Park, be changed to Clay Street.

Section 8. That the name of a certain street now known as Maple Avenue, north of Braddock Road in West Braddock Heights, be changed to Cypress Avenue.

Section 9. That the name of a certain street now known as Mason Place, west from Upland Place in George Washington Park, be changed to Upland Place.

Section 10. That the name of a certain street now known as Monroe Terrace, between King Street Road and South View Terrace, be changed to West View Terrace.

Section 11. That the name of a certain street now known as Old Mount Vernon Avenue, between Glebe Road and City Limits, be changed to Old Dominion Boulevard.

Section 12. That the name of a certain street now known as Myrtle Avenue, between Junior Street and Braddock Road, be changed to Myrtle Street.

Section 13. That the name of a certain street now known as Oak Street, north of Mt. Ida Avenue in Mt. Ida, be changed to Hemlock Avenue.

Section 14. That the name of a certain street now known as Peyton Avenue, between Russell Road and Mt. Ida Avenue, in Mt. Ida and Del Ray, be changed to Del Ray Avenue.

Section 15. That the name of a certain street now known as Royal Avenue, between Glendale Avenue and Windsor Avenue, be changed to Hancock Avenue.

Section 16. That the name of a certain street now known as Seminary View, between Braddock Road and Community Avenue, in Braddock Heights, be changed to Davis Avenue.

Section 17. That the name of a certain street now known as Summit Avenue, between Alexandria Avenue and Braddock Road, be changed to Orchard Street.

Section 18. That the name of a certain street now known as Taylor Drive, west of North View Terrace, be changed to Rucker Place.

Section 19. That the name of a certain street now known as Uhler Terrace, between Russell Road and Alexander Street, be changed to Uhler Avenue.

Section 20. That the name of a certain street now known as Virginia Boulevard, running southward from Glebe Road to its end, in Beverley Hills, be changed to Old Dominion Boulevard.

Section 21. That the name of a certain street now known as Washington Avenue, throughout its entire length, be changed to Commonwealth Avenue.

Section 22. That the name of a certain street now known as Washington Terrace be changed to Park Road.

Section 23. That the name of a certain street now known as Wilson Avenue, between Prince Street and Diagonal Road, be changed to Daingerfield Road.

Section 24. That the name of a certain street now known as Wilson Avenue, in Jefferson Park, be changed to Hayes Street.

Section 25. That the name of a certain street now known as Second Street, between Chestnut Street and Linden Avenue, be changed to Leslie Avenue.

Section 26. That the name of a certain street now known as Third Street, between Chestnut Street and Monroe Avenue, be changed to DeWitt Avenue.

Section 27. That the name of a certain street now known as Old Russell Road, between Kentucky Avenue and Washington & Old Dominion Railroad, be changed to Executive Avenue.

Section 28. That the name of a certain street now known as Russell Place, between Old Russell Road and Washington & Old Dominion Railroad, be changed to Norris Place.

Section 29. That the name of a certain street now known as Valley Drive, between Windsor Avenue and Fontaine Street, in Jefferson Park, be changed to Small Street.

Section 30. That the name of a certain street now known as Valley Place, between Washington Circle and Virginia Boulevard, in Beverley Hills, be changed to Canyon Drive.

Section 31. That the name of a certain street now known as Valley Street, north of Glebe Road, be changed to Montrose Avenue.

Section 32. That the name of a certain street now known as Park Street, east and west of South Washington Street, be changed to Hunting Place.

Section 33. That the name of a certain street now known as Overlook Terrace, north from Braddock Road, in Braddock Heights, be changed to Page Terrace.

Section 34. That the name of a certain street now known as Alto Road, running north from Summers Drive to Alexandria Avenue, be changed to Junior Street.

Section 35. That the name of a certain street now known as Chestnut Street, between Braddock Road and the R. F. and P. R. R. right of way, be changed to Glendale Avenue.

Section 36. That the name of a certain street now known as Craik St., between Russell Road and Braddock Road, be changed to Masonic View.

Section 37. That the name of a certain street now known as Sixth Street, between Jackson Avenue and Monroe Avenue, be changed to Gilpin Street.

Section 38. That the name of a certain street now known as Spruce Street, between Linden Street and Oak Street, be changed to Little Street.

Section 39. That the name of a certain street now known as Reese Street, between Braddock Road and Jackson Avenue, be changed to Ramsey Street.

Section 40. That the name of a certain street now known as Fifth Street, between Jackson Avenue and Linden Avenue, be changed to Ramsey Street.

Section 41. That the name of a certain street now known as Orchard Lane, between High Street and Lloyd Lane, be changed to Orchard Street.

Section 42. That the name of a certain street now known as Belmont Avenue, between Braddock Road and Mt. Vernon Avenue, be changed to Summers Drive.

Section 43. That the name of a certain street now known as Spring Street, between Russell Road and Braddock Road, be changed to Summers Drive.

Section 44. That the name of a certain street now known as Col. Alto Road, running west from Junior Street, be changed to Summers Drive.

Section 45. That the name of a certain street now known as Seventh Street, between Braddock Road and Monroe Avenue, be changed to Newton Street.

Section 46. That the name of a certain street now known as Crestwood Drive be changed to Community Avenue.

Section 47. That the name of U. S. Route No. 1, from Monroe Avenue to the City Limits at Four Mile Run be known as River Road.

Section 48. That the name of Thomas Street shall be conferred upon dedicated forty foot street in Jefferson Park located as follows:

Leading eastward from Valley Drive, parallel to Windsor Avenue, ending at St. Agnes School property line.

Section 49. That this Ordinance shall take effect on the day after its publication in The Alexandria Gazette.
