

Ordinance No. 743

AN ORDINANCE appropriating funds from the several bond accounts of the City of Alexandria, Virginia to be used for acquiring, constructing and equipping public parks; constructing, paving, widening and otherwise improving streets; constructing sanitary and storm water sewers; reconstructing and improving the City Hall and constructing and equipping public buildings for use as fire and police stations; constructing new school buildings and additions to existing school buildings, improving existing school buildings, and acquiring necessary land and equipment; funding valid outstanding notes of the City of Alexandria issued to fund indebtedness evidenced by and included in a Judgment by virtue of an annexation decree made on December 19, 1950 and affirmed December 3, 1951.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That the sum of \$2,595,000.00 be and the same hereby is appropriated from the several bond accounts of the City of Alexandria, Virginia and hereby is allocated for the following purposes:

- (1) From the Public Parks Account to be used in acquiring, constructing and equipping public parks, the sum of \$30,000.00
- (2) From the Public Parks Account (Annexed Area) to be used in acquiring, constructing and equipping public parks in that portion of the City annexed on December 31, 1951 the sum of \$25,000.00
- (3) From the Streets Account (Annexed Area) to be used in constructing, paving, widening and otherwise improving streets in that portion of the City annexed on December 31, 1951 the sum of \$155,000.00
- (4) From the Sanitary and Storm Sewers Account (Annexed Area) to be used in constructing sanitary and storm water sewers in that portion of the City annexed December 31, 1951, the sum of \$240,000.00
- (5) From the Public Buildings Account to be used in reconstructing and improving the City Hall, the sum of \$50,000.00
- (6) From the Public Buildings Account (Annexed Area) to be used in constructing and equipping public buildings for use as fire and police stations in that portion of the City annexed on December 31, 1951, the sum of \$155,000.00
- (7) From the Public Schools Account to be used in constructing new school buildings and additions to existing school buildings, improving existing school buildings, and acquiring necessary land and equipment, the sum of \$840,000.00
- (8) From the Public Schools Account (Annexed Area) to be used in constructing new school buildings and additions to

existing school buildings, improving existing school buildings and acquiring necessary land and equipment in that portion of the City annexed on December 31, 1951, the sum of \$1,000,000.00

- (9) From the Funding Account to be used for funding valid outstanding notes of the City of Alexandria issued to fund \$100,000.00 of indebtedness evidenced by and included in a Judgment against the City of Alexandria entered by an annexation decree made on December 19, 1950, and affirmed by the Supreme Court of Appeals of Virginia on December 3, 1951, the sum of \$100,000.00

Section 2. That before any project calling for the expenditure of the funds appropriated in Section 1 of this ordinance be started, such project must be approved by a majority vote of the Council members present at any lawful meeting of the City Council of Alexandria.

Section 3. That this ordinance shall be published in a newspaper of general circulation in the City not later than two days following its introduction together with a notice containing the time and place for a public hearing. The clerk of the Council shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
