

AN ORDINANCE to amend the Master Plan of the City of Alexandria, Virginia, and amendments thereto, as said Master Plan with all amendments, additions and extensions thereto was validated and confirmed by the Charter of the City of Alexandria, Chapter 536. Acts of Assembly, 1950, by adding thereto a major thoroughfare plan entitled "Major Thoroughfare Plan, A Portion Of The Comprehensive City Plan, City of Alexandria, Virginia," together with a report entitled "Report On A Major Thoroughfare Plan For The City of Alexandria, Virginia, 1952; Part II Of A Comprehensive Plan."

WHEREAS, a major thoroughfare plan for the City entitled "Major Thoroughfare Plan, A Portion Of The Comprehensive City Plan, City of Alexandria, Virginia," together with a report entitled "Report On A Major Thoroughfare Plan For The City of Alexandria, Virginia, 1952; Part II Of A Comprehensive Plan" was duly adopted as a part of the Master Plan of the City of Alexandria, Virginia by a resolution of the City Planning Commission on January 8, 1953, which resolution with said plan and report attached was duly certified to the City Council in accordance with the provisions of Chapter 9, Sec. 9.05 of the City Charter.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

1. That the Master Plan of the City of Alexandria, Virginia, and amendments thereto as said Master Plan with all amendments, additions and extensions thereto was validated and confirmed by the Charter of the City of Alexandria, Chapter 536, Acts of Assembly, 1950, be and the same hereby is amended by adding thereto a major thoroughfare plan entitled "Major Thoroughfare Plan, A Portion Of The Comprehensive City Plan, City of Alexandria, Virginia," together with a report entitled "Report On A Major Thoroughfare Plan For The City of Alexandria, Virginia, 1952; Part II Of A Comprehensive Plan."

2. That the hereinabove approved Plan and Report shall not be deemed to open or establish any street, nor to take any land for street purposes, nor for public use, nor as a public improvement, but solely as a reservation of the street locations shown thereon, for future taking or acquisition for public use.

3. That the Plan and Report above mentioned shall be signed by the Mayor, attested by the Clerk of the Council and the seal of the City of Alexandria affixed thereto.

4. That the Clerk of the Council shall transmit the said Plan and Report along with a duly certified copy of this ordinance to the Clerk of the Corporation Court of the City of Alexandria, and shall request the Clerk to file the same among the Court records.

5. That this ordinance shall be published in a newspaper of general circulation in the City not later than five days following its introduction together with a notice containing the time and place for a public hearing. The Clerk of the Council shall note the date of introduction and first reading, the date of publication, the date of the public hearing, and the date of the second reading and final passage in the minutes of the meeting. This ordinance shall become effective the date of its final passage.
